If you are offered a unit in Tepee Housing, you will be required to pay at least one half of the damage deposit, along with the first month's rent, along with providing proof that you can have power connected prior to check-in. If you are unable to pay these costs within one month of being notified that a unit is available, you may be removed from the waiting list, and the unit possibly allocated to another applicant. It is best you ensure that these requirements can be met, upon being advised of awarding of unit.

It is also your direct responsibility, while on the waiting list, to call or come in to the office during the first week of each month, to update your situation so that we are fully aware that your needs have not changed. Should you fail to report in, as required, your application will be removed from the waiting list, and you will have to re-apply.

The object of Tepee Housing Association is to provide adequate, suitable, low cost housing to residents of Inuvik who are in need.

Those with the most need are housed first

Who May apply?

1. Applicants must reside in Inuvik for six months before their application is reviewed.
2. Applicants must be the full age of nineteen (19) years.
3. Applicants must have a gross family income of less than the following standards to be eligible:
 - a. Bachelor unit..... \$5,125.00
 - b. One Bedroom unit..... \$5,166.00
 - c. Two Bedroom unit..... \$6,541.00

Who will not be accepted?

1. Anyone who has arrears for rent or damage at any other landlord.
2. Anyone who already owns a home or residential property.
3. Anyone who has caused damages or disturbances in their current unit
4. Anyone who gives false or misleading information on this application.
5. Anyone who has been convicted of bootlegging, or drug trafficking.
6. Anyone who has a previous record with the NWT Housing Corporation and is deemed by the Board of Directors to be and 'unsuitable' tenant.
7. Any family larger than 4 persons per unit – CMHC.
8. Anyone who had been evicted from any NWT Housing Association, or any previous Landlord.

I agree to advise Tepee Housing Association of any changes in my income, family size, employment, or changes of address after this form is completed. I understand that the Tepee Housing Association may do a home visit to determine the nature of my current housing.
